CONSISTORY COURT OF THE DIOCESE OF ROCHESTER re Gravesend and Milton Cemetery

Introduction

- In my judgment in this matter, at [2025] ECC Roc I, I gave reasons for dismissing a petition for a faculty for the exhumation of the petitioner's cremated remains from the consecrated portion of the Gravesend and Milton Cemetery for their reinterment in France. The petitioner now seeks permission to appeal. In doing so, she provides some additional information which was not previously put before the court. Some of it appears to be slightly at odds with that which played a material part in my earlier decision.
- 2. For reasons I set out there, the previous judgment followed a rather compressed and abbreviated procedural timetable. Those reasons were good, but nevertheless no longer apply. The new information extends to matters which, if given an opportunity to do so, the petitioner may have put before the court before it made its original decision. In these circumstances, therefore, I have treated the petitioner's application as one to set aside the earlier decision; and to consider the petition afresh in the light of the totality of the evidence.
- 3. As explained in *In re Brookwood Cemetery* [2024] ECC Gui 3, the court has jurisdiction under FJR 20.3 to set aside its decision if it is just and expedient to do so. The importance of the matter to the petitioner is not itself a ground to set aside. However, this is, as that one was, a 'declined permission' rather than 'lost dispute' case; there is no party to be prejudiced by a set-aside or to be vexed by a second action. The new evidence which the petitioner wishes to rely on addresses matters which were relevant to the original refusal of a faculty. I have concluded that, although the original decision was unimpeachable in its application of the legal principles to the evidence then before the court, it would be just and expedient to

set the decision so that the petition could be considered on its merits in the light of all the evidence the petitioner has put before me.

4. I emphasise that this judgment does not arise from a review of the earlier judgment; I have approached the question entirely afresh taking the totality of the evidence into account. Nevertheless, where appropriate, I have addressed the petitioner's new evidence where that comments on the earlier judgment. Rather than requiring the petitioner, and any other reader, to read the earlier judgment alongside this one, I set out again here much of what was said there. This judgment therefore stands alone as the judgment of the court on the renewed petition.

The deceased

His life

- 5. Captain Le Chêne was born in England to French parents in 1900. He served with distinction as a wireless operator in the Special Operations Executive ("SOE") in France where, after capture in late 1942, he was interrogated and tortured before being taken to Mauthausen concentration camp. He survived there for nearly two years until its liberation in May 1945. After the War, it is said that he continued to work for military intelligence, but it is also recorded that he moved to France to open a hotel with his brother and sister-in-law. He was awarded the MBE (Military) and the Croix de Guerre with palm, and received the rare honour of being made an Officier of the Légion d'honneur.
- 6. I noted in the earlier judgment that some of the documents suggest with some authority that he in fact bore the rank of Lieutenant rather than Captain; and some, with rather less authority, that he was the recipient of an OBE, although that is what is recorded on his memorial in the cemetery at Gravesend. His memorial does not accord him a rank, referring simply to his service in the SOE. I further observed that nothing turns on this, and there is no question of any deliberate attempt to mislead me or anyone else. I reiterate that observation. I referred to him throughout as Captain, as that was how he was known to his family and referred to in the petition.

- 7. In response to these observations, the petitioner has provided copies of some documents justifying the use of the rank of Captain and the style of OBE. The following paragraphs set out at some length the basis of the court's remarks in the light of those documents.
- 8. The documents include two dated 11 March 1946 in which the Deputy Assistant Quartermaster-General of SOE (referred to in those documents by its code name of "M.O.I. (S.P.)") refers to him as Captain; these are both in the context of his travel to France a day before the end of his military career. I have also seen a "to whom it may concern" letter from a Major Nicholls of the Defence Intelligence Staff dated 3 March 1969, which appears to say (it is not entirely legible) that he was awarded the OBE for his services in France, giving a reference to the London Gazette of 15 November 1945.
- 9. The London Gazette, which is available online at www.thegazette.co.uk, is the official repository of announcements of (amongst other things) honours and military promotions. I attach to this judgment complete copies of editions 37349 (15 November 1945) and 37496 (12 March 1956). The search facility shows that are no other relevant entries in the London Gazette.
- 10. In the first of these (which is the edition referenced in the letter mentioned in the earlier paragraph), it can be seen (page 5573, right-hand column) that Lieutenant Pierre Louis Le Chêne is listed as one of the "Additional (ie new) Members of the Military Division of the ... Most Excellent Order [of the British Empire]". The army number 221029 is the same as appears on one of the documents referred to earlier.
- 11. The established ranks in the Order of the British Empire are: Knights or Dames Grand Cross (who are entitled to the post-nominal initials GBE); Knights or Dames (KBE or DBE); Commanders (CBE); Officers (OBE); and Members (MBE). Pierre Le Chêne, as a Member of the Order, was entitled to the designation MBE. The 1969 letter from the Defence Intelligence Staff was, in this respect, incorrect.

12. In the 12 March 1946 edition of the London Gazette, at page 1332, right-hand column, it is reported that:

"The undermentioned relinquish their commns [commissions] on ceasing to be employed:-

13 Mar 1946: -

•••

War Subs. Lt. P L Le Chêne (221029) and is granted the hon. rank of Lt."

- 13. I note that his announced decommissioning post-dates, by two days, the SOE travel documents referred to above in which Pierre Le Chêne is referred to as Captain. Whatever the usage may have been within the SOE during his service there, it is clear that in fact on leaving the army he was entitled to use the rank of Lieutenant. This is in accordance with the undated Crown Office document I have been provided with, which is headed "LIEUTENANT PIERRE LOUIS LE CHÊNE. // MEMBER OF THE ORDER OF THE BRITISH EMPIRE. // CITATION."
- 14. I appreciate that these details may come as a surprise or shock to the petitioner. I can only reiterate that none of this has or could have any bearing on my decision on the petition. I have only set it out in such detail to provide further explanation of my earlier observations. I shall continue to refer to the deceased as Captain Le Chêne, as that is how he was known to his family.

After his death

15. Upon the deceased's death in the military hospital in Lyon in 1979, his remains were returned to England to be interred in his wife's home town of Gravesend. A contemporaneous news report provided by the petitioner recorded that this was in accordance with his wishes. I am now told that it was with the assistance of the Memorable Order of Tin Hats (a veterans' association with its roots in the South African forces in the First World War) that he was brought back to Gravesend and interred in 1980. This does not directly contradict the press report; although the petitioner now tells me "[m]y desire was not at that time or now to be buried in Gravesend. Nor was it my late husband's choice." In any event, it clearly appears that it was the petitioner's conscious choice that he be interred there at that time.

The petition

- 16. The petitioner is Evelyn Le Chêne, the widow of Captain Le Chêne. She seeks the exhumation of his cremated remains from the consecrated part of the Gravesend and Milton Cemetery, to be removed to a reserved plot in a consecrated cemetery in Jaillans in the Drôme region of southern France. The petitioner has been provided with a summary of *re Blagdon Cemetery*, and is aware of the approach of the court: that an exception to the principle of permanence must be made out, and that the categories of exception set out there, while not closed, are a useful guide.
- 17. The petition puts forward three grounds, which I set out in full here:
 - a. All the family is here in France. But just as importantly, Pierre was very close to his brother and sister-in-law – all Brits as am I, who lived very close to Pierre and I here in the Drôme, so it would ensure reuniting all the family as I know all of them would have wished, along with specified reserved place in the new grave for myself.
 - When Pierre was dying I promised him that when my time came I would be reunited with him. This had a calming effect for his stress for which I will always be grateful. As I have never had any intention of forgetting that promise – it is written as such in my Will and Testament – his transfer is much, much desired.
 - c. Pierre was the holder of the highest decoration that France can bestow for Courage and Loyalty – the Legion of Honour. He was first Chevalier of the order (a form of Knighthood) then one of the rare Brits to be promoted to Officer rank within the Order which is a mighty promotion indeed for a 'foreigner'! His Award was signed by General de Gaulle himself. Along with that went a Croix de Guerre (War Cross) with Palm and a stretch of others to denote the specific acts for which he was awarded. Local, County

and French State organisations have been waiting to receive Pierre's urn and intend to organise what will be an impressive reception of his remains and installation in France. As I unveiled a Trilogy of memorials last September to British SOE (Intelligence – SOE) agents who died in the Drome during the war, you will readily see the programme that awaits and will coincide with the 80th anniversary of the end of the war.

18. I was also given the following further information:

The Legion of Honour would wish Pierre's transfer to be within their programme of Official Remembrance Ceremonies to commemorate the end of WW2 in Europe and look to the end of May to ensure this if at all possible.

The passage of time now means that this is not relevant.

19. In her further evidence, the petitioner summarises the grounds for the petition in the following way:

The circumstances of the return of the remains of Pierre Louis Le Chêne to England is the result of the promise I gave to my dying husband to be all my life with him. The petition is also the result of this promise.

20. The burial authority, Gravesham Borough Council, has indicated its consent to the petition; and has told me that it would take responsibility for the exhumation and, if necessary, recontainment of the remains, which are said to be in a large casket made to contain the cremated remains of two persons in two separate compartments. I am told that no other interments have taken place in the present grave; the petitioner has the exclusive right of burial there. The council would also take responsibility for the safety and maintenance of the existing memorial thereafter.

Evidence of the petitioner

Passage of time

21. Addressing the question of the passage of time since the interment of Captain Le Chêne, the petitioner tells me that when her husband died in 1979, she had to sell their house in the Drôme and return to the UK to work. Her intention always was to return to France when she was able to purchase a residence there; and she did not want to transfer her husband's remains until she had finally established herself there. While I am not told when that was, I note from the documents that the right of interment in the cemetery in Jaillans was only secured in late 2024.

Mistake or change of mind

- 22. Addressing the question of whether this case can be characterised as one of mistake or change of mind, the petitioner agrees this is not a matter of a mistake. She also says that it is not a matter of a change of mind. As set out in paragraph 19 above, both his interment in Gravesend and the petition to move his remains to France are the result of the promise she gave to her dying husband to be all her life with him.
- 23. Her desire was not at that time or now to be buried in Gravesend, nor was it her late husband's choice. When he died in the military hospital in Lyon, she was grateful to have assistance from the Memorable Order of Tin Hats. It was they who, in communication with the Commonwealth War Graves Commission, made the preparations for the interment in Gravesend Cemetery.

Permanence

24. The petitioner notes that the 50-year concession in the cemetery in Jaillans can be extended to last in perpetuity; citing Article L2223-14 of the General Code of Local Authorities, a copy and translation of which she helpfully provides. The court is not expert in French law, but on a straightforward reading of the text of that Article this appears not necessarily to be the case; there is no obligation on the municipality to offer concessions in perpetuity. However, as I did in my earlier judgment, I am

prepared to assume in the petitioner's favour that such an extension could be secured.

French honours

- 25. In my earlier judgment, I had acknowledged the distinction of being a non-French appointee as Officier of the Légion d'honneur. I had concluded, however, that this in itself was not a reason for his exhumation and reinterment in France; indeed, it could be said that to accede to the petition on this ground would be to treat the remains as portable, their transport to and arrival in France being itself something to be celebrated.
- 26. The petitioner now adds that to consider that the French authorities were pushing on the exhumation and transfer of the deceased's remains to France was an error, and off-topic. I appreciate the clarification; the view expressed in my earlier judgment, that any such pressure would not amount to a reason for exhumation, still stands.

Evidence of Christophe Le Chêne

- 27. I have been provided with written evidence from the petitioner's son in support of the petition, in which he sets out that his father wished to be buried with his mother, but that he never indicated that he wished that to be in England. Further, he explains that he and his family would be unable to travel the distance to Gravesend to visit the grave it is said, resulting in his parents being isolated from other members of the Le Chêne family.
- 28. As I explained in my earlier judgment, I proceeded on the basis that the petitioner's son supported the petition. To that extent, his evidence adds little to my considerations, but I am grateful to have it and I take it into account.

Determination

29. The starting point for my consideration of this petition must be the Court of Arches decision in *re Blagdon Cemetery* [2002] Fam 299. That decision is binding on me. It

explains that there is a general presumption that Christian burial is permanent, and the necessary faculty for exhumation from consecrated ground will only be given in circumstances sufficiently compelling as to properly justify making an exception to that permanence. Ultimately, it is a matter for the exercise of the court's discretion, albeit against the background of the clear presumption in favour of the permanence of burial. Any notion that remains are to be regarded or treated as in any way "portable" is to be resisted.

- 30. It is plainly desirable that, so far as is reasonably possible, there should be consistency in decisions: similar cases should generally be decided similarly. *re Blagdon Cemetery* itself makes this point. However, as recently observed in *re Kidderminster, St George* [2022] ECC Wor 10: "[i]t has to be said that it is not particularly easy to find a clear path through the reported decisions of Chancellors who endeavour to balance the doctrine of the permanence of Christian burial with the understandable desires of petitioners in their various circumstances." The Chancellor there rightly paid particular attention to reported decisions of the consistory court of her own diocese. However, I have found no reported decisions from this diocese on exhumation on which I can put particular weight.
- 31. In exercising my discretion, therefore, I consider the following factors, among those identified in *re Blagdon Cemetery*, to be relevant. In doing so, I remind myself that any factors in favour of granting a faculty can operate cumulatively; that is, even though any single factor may not be sufficient to constitute an exception to the presumption of permanence, the combination of factors may nevertheless be sufficient.

Lapse of time

32. While the Court of Arches in *re Blagdon Cemetery* said that lapse of time is not determinative, it can be a factor militating against the grant of such a faculty. In this case, some 45 years have passed since Captain Le Chêne's ashes were interred in Gravesend. At the time of my earlier judgment, I had no evidence of why so much time had passed.

- 33. I set out at paragraph 21 above the evidence I have now been given. The new material is helpful, to a degree, in understanding the relevant sequence of events. However, the narrative has no timeline, and it is hard not to have the sense that I am not getting the full picture. Research in publicly-available records discloses that the petitioner's first marriage to Captain Le Chêne in 1965; her marriage to her second husband in 1976; and her re-marriage to Captain Le Chêne in 1978; were all registered in Gravesend (which, I note from his French citizenship card, was also the birthplace of Christophe in 1956). She was still registered to vote in Gravesend in 2003-2004. I am not told when she returned to France; the cemetery concession in France was only obtained last year, but my impression is that she relocated significantly longer ago than that.
- 34. It appears that the explanation for the passage of time lies simply in what she said, set out at 19 above: she wished the deceased's remains to be near her while she lived in Gravesend; and now she lives in France, she wishes them to be near her there. This would explain why the petition was not brought until she reestablished herself in France; but not why it was not brought until now. I am not persuaded that there is a good explanation for what, on any view, must be a significant passage of time within which this petition could have been brought; and the passage of time does militate against a grant of a faculty.

Mistake

- 35. Where there has been a mistake as to the intended location of an interment (such as, for example, interment in a grave reserved for another), or as to the nature of the interment (such as, for example, an interment in consecrated ground when due to the deceased's religious or other beliefs that was inappropriate), grounds for exhumation may readily be made out.
- 36. However, the court in re Blagdon Cemetery expressly said that:

... a change of mind as to the place of burial on the part of relatives or others responsible in the first place for the interment should not be treated as an acceptable ground for authorising exhumation.

- 37. As I noted in the earlier judgment, there is no suggestion of any operative mistake; and the petitioner expressly denies any such mistake. Captain Le Chêne appears to have had a life established in France since shortly after the war, along with his brother and sister-in-law with whom I am told he was in the hotel business. Despite this settled life for at least three decades, his remains were returned to England, and to his wife's home town, for interment in a grave in which the petitioner had obtained the exclusive right to interment. It would be impossible to discern, at this distance in time, whether this was in reluctant fulfilment of the deceased's wish or whether it accorded wholeheartedly with the petitioner's wishes. However, I do note that the casket in which his remains are interred is designed to accommodate a second set of remains, which would accord with her evidence that she promised the deceased that she would be interred with him. It would appear objectively, therefore, that she must then have been content that both he and she would be interred in Gravesend when her time came.
- 38. To the extent that mistake and change of mind are a dichotomy, it does appear that the motivation behind the present petition can be better characterised as a change of mind than a mistake. Certainly, the absence of an operative mistake does not assist the petitioner.

Family graves

39. The court in *re Blagdon Cemetery* recognised that family graves both express family unity and represent an economical use of land for burials; and it considered that the creation of a family grave might constitute sufficient reason to permit exhumation. (In both *re Blagdon Cemetery* and the present case, the exhumed remains would be the first interment in the new, family grave.) 40. I am satisfied that there is the necessary legal right for a family grave to be established in Jaillans. But this cannot take away from the fact that there is already a family grave in Gravesend, where there is a casket designed to take the petitioner's cremated remains when her time comes; in a plot where the petitioner has already secured the right of interment. In circumstances where exhumation is not a necessary precursor to the creation of a family grave, this factor does not significantly assist the petitioner.

Suitability of place of reinterment

- 41. In *re Blagdon Cemetery*, a distinction was drawn between reinterment in a local authority cemetery, which is subject to statutory control, and reinterment elsewhere, where no general inference of the suitability for reinterment can properly be drawn by the consistory court.
- 42. In this case, the proposed reinterment would be in a civil cemetery in France. In *re Streatham Park Cemetery* (2011, Southwark Consistory Court), Petchey Ch. considered a petition for exhumation where reinterment would be in a cemetery in Belgium. In terms which demonstrate parallels with the present case, he said:
 - "39. In the present case, I can assume that the re-interred remains will be in a grave that will be suitably maintained but I cannot be certain as to what will happen to them after 50 years. I think it likely that, if as one might hope, there are still members of the family around who keep the memory of [the deceased] alive, they would purchase an extension of the right of interment. But I have to face the possibility that, sooner or later, the remains might come to a common grave. This, as I understand it, is the tradition in Belgium.
 - 40. I think that by permitting exhumation in these circumstances I am contemplating the erosion, to a degree, of the principle of the permanence of Christian burial within the Anglican tradition. Nonetheless, if the remains were to end in a common grave it would be many years after they had been exhumed in England and at a time when, sadly, no one

thought it important that this should not happen. I do not think that this is a significant erosion of the principle of permanence."

- 43. I had concluded that reinterment in a place where the concession to permit interment is, at least initially, only for 50 years would represent some erosion of the principle of permanence; and the fact that the remains would then be outside the jurisdiction of both the ecclesiastical and the civil courts gives additional pause for thought. Whether that would be enough to tip the scales in a balance which was otherwise in favour of exhumation is open to doubt, of course; it did not do so in *re Streatham Cemetery*.
- 44. However, as discussed at paragraph 24 above, I am prepared to assume in the petitioner's favour that an extension could be secured, providing a concession in perpetuity. In any event, I am satisfied that the cemetery in Jaillans would, in principle, be a suitable location for the interment of remains, and this would present no obstacle to the present petition, were the other factors in its favour.

Other factors

- 45. In my earlier judgment I did consider whether, while not falling into any of the categories set out in *re Blagdon Cemetery*, grounds for an exception to the permanence of burial can be identified in the deceased's wartime service, coupled with the honours bestowed on him by the French state and the reported wish of the local and national authorities in France to mark the arrival and interment of the remains there. As noted at paragraph 25 above, the petitioner has now indicated that this is not a factor I should consider, so I say no more about it.
- 46. I have noted from some of the photographs accompanying the petitioner's recent evidence that it appears that a memorial to Captain Le Chêne has already been created and installed at the proposed reinterment site. This has not been mentioned by the petitioner, and has not been put forward as a reason in support of the petition; if it had, I could have placed no weight on it.

Conclusion

- 47. At its heart, this petition arises from the petitioner's strongly-expressed wish to fulfil her promise to her late husband, that they would always be together. While she was established in Gravesend, that promise was maintained through his interment in Gravesend; now she is established in France, she wishes his remains to be there, for the same reason.
- 48. With some regret, I must conclude that it would be wrong to grant this petition. It would be quintessentially to treat Captain Le Chêne's remains as portable precisely the denial of the principle of permanence that I am required by binding authority to guard against. None of the other matters raised by the petitioner or her son, either singly or in combination, persuade me otherwise.
- 49. I must, therefore, dismiss the petition.

Procedural matters

- 50. This decision will not stand in the way of the petitioner's remains resting with his, in due time. The existing casket will need to be exhumed so that her remains can be placed in it for burial; and that temporary exhumation will need to be pursuant to a faculty. However, I direct that a letter from her executor to the Registry shall suffice for a petition for such a faculty; and that no further fee shall be payable.
- 51. This judgment arises from the petitioner's request for permission to appeal my earlier judgment; and I am aware that the petitioner may feel that she has not got what she asked for. I hope she will understand that the approach I have taken has favoured her in three distinct ways.
- 52. First, her petition has been considered entirely afresh, rather than merely reviewed to see whether it fell outside the wide ambit of decisions I could properly have come to (which is what an appeal would have been). Secondly, I have been able to take into account all the additional evidence she wished to put before me, which would not have been possible on an appeal. Finally, the petitioner retains the right to seek permission to appeal this fresh judgment. Should she do so, for pastoral reasons the

court will waive the relevant fee, which she has already paid on the present application.

53. In the circumstances, I again waive my fee for writing this judgment.

On the 19th of May, 1941, at Colito, Abyssinia, two companies of the 1st/6th The. King's African Rifles successfully crossed the Billate River in the face of strong enemy opposition, and established a precarious bridgehead without hope of immediate reinforcement.

the Throughout operation, Sergeant Leakey had been supporting the crossing with 3 in. mortar fire, and having expended all his ammunition, he went forward to see what he could do.

Suddenly, the enemy launched a surprise . counter-attack with medium and light tanks which emerged from the bush threatening to over-run the two companies of the 1st/6th The King's African Rifles.

Advancing from the rear, one of these tanks was bearing down on the troops, who had no anti-tank weapons for their defence.

With complete disregard for his own safety, and in the face of withering machine gun and rifle fire from the enemy's ground troops, and from more tanks in front, Sergeant Leakey leaped on top of the tank which was coming in from behind our position and wrenched open the turret.

With his revolver he shot the Commander of this tank and the crew with the exception of the driver whom he forced to drive in to cover.

Having failed to get the cannon of this tank to fire he dismounted, calling out "I'll get them on foot," and charged across ground which was being swept by machine gun and shell fire from the other enemy tanks which were advancing and causing casualties to our infantry.

In company with an African C.S.M. and two other Askari, he proceeded to stalk these tanks. The first two tanks passed, but Sergeant Leakey managed to jump on to the third tank and opened the turret and killed one of the crew before the fourth tank opened fire with a machine gun and shot him off the tank.

Sergeant Leakey throughout the action displayed valour of the highest order, his determination and his initiative were entirely responsible for breaking up the Italian tank attack; by his own individual action he saved what would have undoubtedly developed into a most critical situation, for had the Italian tanks succeeded the result would have been the loss of a most valuable bridgehead which would have had most far reaching results on the subsequent operations.

The superb courage and magnificent fighting spirit which Sergeant Leakey displayed, facing almost certain death, was an incentive to the troops who fought on with inspiration after witnessing the gallantry of this N.C.O.'s remarkable feat, and succeeded in retaining their positions in face of considerable odds.
